Interferon- α 2a (IFN- α 2a) (Human)

Description:

At least 23 different variants of IFN- α are known. The individual proteins have molecular masses between 19-26 kDa and consist of proteins with lengths of 156-166 and 172 amino acids. All IFN- α subtypes possess a common conserved sequence region between amino acid positions 115-151 while the amino-terminal ends are variable. Many IFN- α subtypes differ in their sequences at only one or two positions. Naturally occurring variants also include proteins truncated by 10 amino acids at the carboxy-terminal end.

Reconstitution:

We recommend that this vial be briefly centrifuged prior to opening to bring the contents to the bottom. Reconstitute in sterile distilled water or aqueous buffer containing 0.1% BSA to a concentration of 0.1-1.0 mg/mL. Stock solutions should be apportioned into working aliquots and stored at $< -20^{\circ}\text{C}$. Further dilutions should be made in appropriate buffered solutions.

Formulation:

Lyophilized from a 0.2 μ m filtered solution in PBS, pH 7.4.

Storage:

This lyophilized preparation is stable at 2-8 $^{\circ}\text{C}$, but should be kept at -20 $^{\circ}\text{C}$ for long term storage, preferably desiccated. Upon reconstitution, the preparation is stable for up to one week at 2-8 $^{\circ}\text{C}$. For maximal stability, apportion the reconstituted preparation into working aliquots and store at -20 $^{\circ}\text{C}$ to -70 $^{\circ}\text{C}$. Avoid repeated freeze/thaw cycles.

Molecular Weight:

Approximately 19.2 kDa, a single non-glycosylated polypeptide chain containing 165 amino acids.

Endotoxin:

Less than 1 EU/ μ g of IFN- α 2a as determined by LAL method.

Usage:

Biological Activity:

The specific activity determined by an anti-viral assay is no less than 1.0×10^8 IU/mg.

Sterile filtered white lyophilized (freeze-dried) powder.
