Interferon- λ 1/IL-29 (IFN- λ 1/IL-29) (Human) Cat. No. HEILP-29011





Description:

IL-28A, IL-28B, and IL-29, also named interferon- $\lambda 2$ (IFN- $\lambda 2$), IFN- $\lambda 3$, and IFN- $\lambda 1$, respectively, are newly identified class II cytokine receptor ligands that are distantly related to members of the IL-10 family (11-13% aa sequence identity) and the type I IFN family (15-19% aa sequence identity). The expression of IL-28A, B, and IL-29 is induced by virus infection or double-stranded RNA. All three cytokines exert bioactivities that overlap those of type I IFNs, including antiviral activity and up-regulation of MHC class I antigen expression. The three proteins signal through the same heterodimeric receptor complex that is composed of the IL-10 receptor β (IL-10 R β) and a novel IL-28 receptor α (IL-28 R α , also known as IFN- λ R1). Ligand binding to the receptor complex induces Jak kinase activation and STAT1 and STAT2 tyrosine phosphorylation.

Reconstitution:

We recommend that this vial be briefly centrifuged prior to opening to bring the contents to the bottom. Reconstitute in sterile distilled water or aqueous buffer containing 0.1% BSA to a concentration of 0.1-1.0 mg/mL. Stock solutions should be apportioned into working aliquots and stored at < -20°C. Further dilutions should be made in appropriate buffered solutions.

Formulation:

Lyophilized from a 0.2 μ m filtered concentrated solution in PBS, pH 7.4.

Storage:



This lyophilized preparation is stable at 2-8°C, but should be kept at -20°C for long term storage, preferably desiccated. Upon reconstitution, the preparation is stable for up to one week at 2-8°C. For maximal stability, apportion the reconstituted preparation into working aliquots and store at -20°C to -70°C. Avoid repeated freeze/thaw cycles.

Molecular Weight:

Approximately 19.8 kDa, a single non-glycosylated polypeptide chain containing 181 amino acids.

Endotoxin:

Less than 1 EU/µg of IFN- λ 1/IL-29 as determined by LAL method.

Usage:

Biological Activity:

The ED50 determined by an anti-viral assay using human HepG2 cells infected with encephalomyocarditis is less than 5 ng/mL, corresponding to a specific activity of > 2.0×10^5 IU/mg.

Sterile filtered white lyophilized (freeze-dried) powder.
