


# User Manual

B-Cell Maturation Antigen (BCMA) (Human) Cat. No. HEOPP-02032





## **Description:**

B-Cell Maturation Antigen (BCMA), a member of the TNF receptor superfamily, binds to BAFF and APRIL. BCMA is expressed on mature B-cells and other B-cell lines and plays an important role in B cell development, function and regulation. BCMA also has the capability to activate NF-kappaB and JNK. The human BCMA gene codes for a 184 amino acid type I transmembrane protein, which contains a 54 amino acid extracellular domain, a 23 amino acid transmembrane domain, and a 107 amino acid extracellular domain.

### Reconstitution:

We recommend that this vial be briefly centrifuged prior to opening to bring the contents to the bottom. Reconstitute in sterile distilled water or aqueous buffer containing 0.1% BSA to a concentration of 0.1-1.0 mg/mL. Stock solutions should be apportioned into working aliquots and stored at < -20°C. Further dilutions should be made in appropriate buffered solutions.

### Formulation:

Lyophilized from a 0.2 μm filtered concentrated solution in 30% acetonitrile, 0.1% TFA.

## Storage:

This lyophilized preparation is stable at 2-8°C, but should be kept at -20°C for long term storage, preferably desiccated. Upon reconstitution, the preparation is stable for up to one week at 2-8°C. For maximal stability, apportion the reconstituted preparation into working aliquots and store at -20°C to -70°C. Avoid repeated freeze/thaw cycles.

## **Molecular Weight:**

Approximately 5.3 kDa, a single non-glycosylated polypeptide chain containing 50 amino



acids.

## **Endotoxin:**

Less than 1 EU/μg of BCMA as determined by LAL method.

# **Biological Activity:**

The ED50 determined by its ability to inhibit APRIL-mediated proliferation of anti-IgM stimulated murine B cells is no less than 40 ng/mL, corresponding to a specific activity of >  $2.5 \times 10^4$  IU/mg in the presence of 100 ng/mL human APRIL.

# **Physical Appearance:**

Sterile filtered white lyophilized (freeze-dried) powder.
