Interleukin-8 (IL-8) (Rhesus macaque)

Description:

Interleukin-8 (C-X-C motif chemokine 8) is coded by the interleukin 8 gene on the chromosome 5 in Rhesus macaque (*Macaca mulatta*), which is not only 94% identical to human IL-8 but also structurally and functionally similar with the human equivalent. Provide a valuable resource for a primate model of inflammation.

Source:

Escherichia coli

Reconstitution:

We recommend that this vial be briefly centrifuged prior to opening to bring the contents to the bottom. Reconstitute in sterile distilled water or aqueous buffer containing 0.1% BSA to a concentration of 0.1-1.0 mg/mL. Stock solutions should be apportioned into working aliquots and stored at < -20°C. Further dilutions should be made in appropriate buffered solutions.

Formulation:

Lyophilized from a 0.2 µm filtered concentrated solution in PBS, pH 7.4.

Storage:

This lyophilized preparation is stable at 2-8°C, but should be kept at -20°C for long term storage, preferably desiccated. Upon reconstitution, the preparation is stable for up to one week at 2-8°C. For maximal stability, apportion the reconstituted preparation into working aliquots and store at -20°C to -70°C. Avoid repeated freeze/thaw cycles.

Molecular Weight:

Approximately 9.14kD containing 79 amino acid residues.

Endotoxin:

Less than 1 EU/ μ g of IL-8 as determined by LAL method.

Usage:

Biological Activity:

The biologically active determined by a chemotaxis bioassay using human CXCR2 transfected murine BaF3 cells is in a concentration range of 0.5-5.0 ng/mL.

Sterile filtered white lyophilized (freeze-dried) powder.
