**Eotaxin-2/CCL24 (Eotaxin-2/CCL24) (Human)**

**Description:**

Eotaxin-2/CCL24, also named MPIF-2 and Ck $\beta$ 6, is a novel CC chemokine recently identified. It is produced by activated monocytes and T lymphocytes. Eotaxin-2 selectively chemoattracts cells expressing CCR3 including eosinophils, basophils, Th2 T cells, mast cells, and certain subsets of dendritic cells. Additionally, Eotaxin-2 inhibits the proliferation of multipotential hematopoietic progenitor cells. The mature protein, which also includes a C-terminal truncation, contains 78 amino acid residues (92 a.a. residues for the murine homolog, without C-terminal truncation).

**Reconstitution:**

We recommend that this vial be briefly centrifuged prior to opening to bring the contents to the bottom. Reconstitute in sterile distilled water or aqueous buffer containing 0.1% BSA to a concentration of 0.1-1.0 mg/mL. Stock solutions should be apportioned into working aliquots and stored at < -20°C. Further dilutions should be made in appropriate buffered solutions.

**Formulation:**

Lyophilized from a 0.2  $\mu$ m filtered concentrated solution in 20 mM PB, pH 7.4, 150 mM NaCl.

**Storage:**

This lyophilized preparation is stable at 2-8°C, but should be kept at -20°C for long term storage, preferably desiccated. Upon reconstitution, the preparation is stable for up to one

week at 2-8°C. For maximal stability, apportion the reconstituted preparation into working aliquots and store at -20°C to -70°C. Avoid repeated freeze/thaw cycles.

**Molecular Weight:**

Approximately 8.8 kDa, a single non-glycosylated polypeptide chain containing 78 amino acids.

**Endotoxin:**

Less than 1 EU/μg of Eotaxin-2/CCL24 as determined by LAL method.

**Usage:**

**Biological Activity:**

The biologically active determined by a chemotaxis bioassay using human peripheral blood eosinophils is in a concentration of 50-100 ng/mL.

Sterile filtered white lyophilized (freeze-dried) powder.
