


# User Manual

beta-Defensin 3 (BD-3) (Human) Cat. No. HEOPP-02063





## **Description:**

Defensins (alpha and beta) are cationic peptides with a broad spectrum of antimicrobial activity that comprise an important arm of the innate immune system. The  $\alpha$ -defensins are distinguished from the  $\beta$ -defensins by the pairing of their three disulfide bonds. To date, four human  $\beta$ -defensins have been identified: BD-1, BD-2, BD-3 and BD-4.  $\beta$ -defensins are expressed on some leukocytes and at epithelial surfaces. In addition to their direct antimicrobial activities, they are chemoattractant towards immature dendritic cells and memory T cells. The  $\beta$ -defensin proteins are expressed as the C-terminal portion of precursors and are released by proteolytic cleavage of a signal sequence and, in the case of BD-1 (36 a.a.), a propeptide region.  $\beta$ -defensins are 3-5 kDa peptides ranging in size from 33-47 amino acid residues.

# **Reconstitution:**

We recommend that this vial be briefly centrifuged prior to opening to bring the contents to the bottom. Reconstitute in sterile distilled water or aqueous buffer containing 0.1% BSA to a concentration of 0.1-1.0 mg/mL. Stock solutions should be apportioned into working aliquots and stored at < -20°C. Further dilutions should be made in appropriate buffered solutions.

# **Formulation:**

Lyophilized from a 0.2  $\mu m$  filtered concentrated solution in 20 mM PB, pH 7.4, 130 mM NaCl.

#### Storage:

This lyophilized preparation is stable at 2-8°C, but should be kept at -20°C for long term storage, preferably desiccated. Upon reconstitution, the preparation is stable for up to one



week at 2-8°C. For maximal stability, apportion the reconstituted preparation into working aliquots and store at -20°C to -70°C. Avoid repeated freeze/thaw cycles.

### **Molecular Weight:**

Approximately 5.1 kDa, a single non-glycosylated polypeptide chain containing 45 amino acids.

# Endotoxin:

Less than 1 EU/ $\mu$ g of BD-3 as determined by LAL method.

# **Biological Activity:**

The ED50 determined by anti-microbial activity against E.coli. is less than 30  $\mu$ g/mL, corresponding to a specific activity of > 33.3 IU/mg.

Sterile filtered white lyophilized (freeze-dried) powder.
